

The inspection of the proposed building was carried out by the undersigned Assistant Executive Engineer on 21.01.2025 with their sub-divisional technical team and Infra Support Engineering Consultants Pvt. Ltd (An ISO 9001-2015 Certified company) NDT Report dated 17.01.2025, the inspection of stability of the building #206/48, Canara Bank Layout, Sri Ammembal Subbarao Pai Nagar, Bangalore-560097 was carried out as per the Government circular No. LoE 59 BED 2019, dated 06.05.2022 in collaboration with the registered firm Infra Support Engineering Consultants Pvt.
